  - Copy of 12th Std. Mark statement.

The admission to the Third Semester of BBA LLB program at UWSL will be decided on the basis of evaluation report of student's marks scored in his 12<sup>th</sup> Std., first semester and second semester of five years integrated BBA LLB (Hons.) program examination as well as the equivalence of the programme pursued by the student at the previous institute with that of UWSL.

  - 12th Std. Mark statement in original
  - One time transfer fee of Rs. 5,000/-
  - Third Semester fee of Rs. 100,000/-
